GOVERNING BODIES OF GOVERNMENT ARTS COLLEGES IN BENGAL.

I HAVE the honour to invite reference to Government letter No. 1779, dated the 22nd March 1909, in which sanction was accorded to the constitution and functions of governing bodies for the Government Colleges at Patna, Hooghly, Krishnagar and Cuttack and the Sanskrit College at Calcutta, in terms of the recommendations made in paragraph 7 of my letter No. 20810, dated the 17th November 1908.

2. I have now to forward my nominations as to the members of the staff of each college who should be appointed to the governing bodies of their respective colleges. The appointments should, I suggest, be made for the academic year 1909-10 in the first place and thereafter be subject to renewal or revision annually—appointment in all cases being renewed or fresh appointments made before the end of the academic year, that is, before the long vacation.

Patna College.

Previous to the transfer of Messrs. Little and Russell to Patna College, on their return from leave after the Pujah vacation, Mr. Jackson, the officiating Principal, in consultation with the Commissioner of the Patna Division, nominated Professor Jadu Nath Sarkar and Maulvi Abdul Hai to be members of the governing body. Having regard, however, to the present constitution of the staff of the college, I propose that Messrs. Russell and Jackson be appointed to represent the professional staff on the governing body.

Hooghly College.

4. In conclusion I may add that the members of the staffs of the colleges enumerated above have in each case been nominated by me in consultation with the President of the governing body and the Principal of the College concerned.

5. The case of Presidency College, which was also dealt with in the Government letter cited in paragraph 1, has, as Government is aware, been submitted separately.
